Western Hemisphere Migratory Species Initiative (WHMSI) Interim Steering Committee Meeting June 5-6 2007 Minutes

Attending: ISC members: Herb Raffaele-Chair (U.S.); Jorge Luis Cravino (Uruguay); Donald Anthony (St. Lucia); Carlos Drews (WWF); David Pashley (American Bird Conservancy); Charles Duncan (Western Hemisphere Shorebird Reserve Network); Alberto Yanosky (Guyra Paraguay-Birdlife); Richard Huber (OAS). Other attendees: Scott Vaughan (OAS), Marina Ratchford (USFWS), Brian Hayum (USFWS) and Carolina Peña (OAS).

Tuesday May 5th

Raffaele and Vaughan opened the meeting, followed by introductions by participants, including new members. Alberto Yanosky will now serve as Birdlife representative in the ISC. Jenny Asch represented Costa Rica (J.J. Calvo was attending CITES). Representatives from Colombia, Ramsar, IAC, UNEP-SPAW and CMS could not attend due to scheduling conflicts.

Drews and Duncan made presentations on WHMSI-related activities being conducted by their programs. Drews' presentation on adaptation to climate change (management of fishing stocks, rising sea levels and Caribbean biodiversity, changes to water streams) triggered animated discussion on possible collaboration with other species initiatives.

Huber and Ratchford provided an update on the GEF and other potential sources of funding for the WHMSI capacity building proposal developed with input from the Second WHMSI Conference of 2006. Huber and Vaughan summarized the new GEF Biodiversity strategy and announced that Gustavo da Fonseca will be GEF's Biodiversity Team Leader starting on July 1st. The GEF is presently not funding regional projects, and the participants agreed that it would not be practical to continue pursuing the GEF as a source of funding at this time. Vaughan offered assistance to draft other WHMSI proposals for the GEF as appropriate, focusing on medium-sized projects. He also offered to host a policy and donor oriented meeting on migratory species at the OAS in the future.

Raffaele announced that the USFWS Wildlife Without Borders Latin America/Caribbean and Mexico programs have recently undergone strategic planning processes and will focus their future funding on capacity building in and around protected areas, addressing many of the same audiences and themes identified in the WHMSI capacity building proposal. The group also discussed the possibility of exploring other sources of funding such as Ramsar's Wetlands for the Future program and the Neotropical Migratory Bird Conservation Act program. Some participants considered the possibility of approaching foundations such as Moore and MacArthur.

The group also dedicated some time to discuss the Neotropical Migratory Bird Conservation Act (NMBCA) program, and the need to include more input from Latin

American countries. Duncan and Pashley explained that NMBCA favors initiatives focused on umbrella species and coordinated by large NGOs, which provide continuity to projects and send funding to local NGOs.

Participants next discussed other action items from WHMSI 2, going through an extensive list of subject areas and identifying who will help to implement some of the suggested follow up actions. As a result of this discussion, Drews will draft a brief document (~4 pages) on the value of migratory species and will include suggestions for a WHMSI logo. See attached list for other action items and responsibilities regarding follow up to WHMSI 2.

ISC members focused next on the draft Terms of Reference. It was agreed that given the unofficial nature of the document, it should be renamed "Purpose and Organization". Members discussed main comments and issues to resolve, and agreed on a process to address them. Incorporation of comments by Mexico and Argentina will be highlighted in the latest draft of the document and Raffaele will send a copy of this marked document to WHMSI focal points in these two countries (with cc to any other Mexican and Argentine government representatives involved in WHMSI) explaining any changes and inviting them to discuss this further in person. ISC members will receive a copy of these letters.

Members also agreed to include a sentence on "facilitation" within the guiding principles section.

Wednesday June 6th

Participants discussed the WHMSI relevant language from the Ministerial on Sustainable Development that took place in Bolivia in December 2006 and agreed that it should serve as a useful reference to promote implementation of WHMSI.

The next topic was a discussion of selected relevant upcoming meetings where WHMSI should be represented and/or organize side events. Specific events such as the Latin American Parks Congress in Bariloche and the PIF Conference in Texas will likely be attended by one or more ISC members, and participants agreed to make WHMSI presentations within their own sessions. In this regard, Ratchford will send an updated version of the WHMSI power point slides, incorporating Bolivia ministerial language, link to related Conventions (with text to be provided by Huber), and value of migratory species (text provided by Drews).

The final item of the meeting was a brainstorming on agenda, date, location and funding for WHMSI 3, resulting in the following outline:

Proposed Date: April-May 2008

Location: Trinidad & Tobago, Panama, Paraguay, or Ecuador

<u>Participants:</u> WHMSI focal points from 35 countries in the Western Hemisphere, ISC members, and all interested Convention and NGO partners. ISC members will reach out to selected indigenous groups and encourage them to participate as well.

Draft AGENDA

Note: WHMSI 3 will seek to facilitate coordination among related migratory species initiatives (WHSRN, PIF, Birdlife, Sea Turtles, Waterbird Council, others) by helping to organize side meetings before and after the official conference. The goal is to foster synergies for better collaboration and more efficient use of resources and to maximize Latin American participation in these initiatives.

WHMSI's Interim Steering Committee will meet in the afternoon of the day before Day 1 of the official conference.

 - 3.2 Other resources
 - 4. Presentations by key donors on their migratory species interests
 - 5. Partnerships: Signed MOUs, outreach to other migratory species networks

Day 2: Field Trip

Days 3 and 4:

Thematic sessions with up to 2 themes per day. Working groups will address specific themes, including background presentations/case studies, group discussions and recommendations, incorporation of input and buy-in of governments and NGOs, and proposed follow-up for potentially joint projects.

Some potential themes include:

- Adaptation to climate change
- Interaction among marine conservation initiatives for migratory species (e.g. ACAP, albatross & petrel, etc.)
- Monitoring

- Capacity strengthening in project development and management for grass roots NGOs
- Invasive species
- Avian influenza
- Guidance to relevant funding programs (e.g. Neotropical Migratory Birds Conservation Act) from LAC

The process for selecting themes will be through a request for short papers (1-2 pages) that describe the proposed thematic sessions. These papers should include:

- justification/importance of theme
- targeted audience
- proposed case studies
- role of governments
- expected outcomes and follow up
- main organizer and collaborators

Afternoon of Day 4: Closing of Conference

<u>Funding:</u> Yanosky will explore the possibility of obtaining CIDA support for the conference.
