**I. ORIGEN**

El Consejo Interamericano para el Desarrollo Integral fue creado a través del Protocolo de Managua, aprobado por la Asamblea General en Nicaragua en junio de 1993. Fue ratificado el 29 de enero de 1996, en la Vigésimo Segunda Asamblea General Extraordinaria en Washington. El CIDI promueve la “cooperación” entre sus estados miembros para el avance de su desarrollo integral y en particular, ayudar a eliminar la pobreza. Logra sus objetivos a través del Plan Estratégico para el Desarrollo Integral. El Estatuto del CIDI fue aprobado a través de la resolución AG/RES. 1443 (XXVI-O/96) durante la Asamblea General en Panamá en junio de 1996.

La Comisión Ejecutiva Permanente (CEPCIDI) es el cuerpo ejecutivo permanente del CIDI. CEPCIDI, de acuerdo al Artículo 7 del Estatuto del CIDI, adopta decisiones y efectúa recomendaciones para la planificación, programación presupuestaria, control gerencial, seguimiento y evaluación de los proyectos de cooperación y actividades ejecutadas en el ámbito del CIDI.

El Artículo 11 del Estatuto del CIDI dispone que las Comisiones Especializadas No Permanentes (CENPES) son cuerpos técnicos que apoyan al CIDI en asuntos especializados o en desarrollar aspectos específicos de la cooperación interamericana en áreas prioritarias de cooperación aprobadas por la Asamblea General. Los CENPES analizan las actividades propuestas y las somete a CEPCIDI con sus recomendaciones.

El Fondo Especial Multilateral del Consejo Interamericano para el Desarrollo Integral (FEMCIDI) fue establecido para contribuir al financiamiento de programas de cooperación nacional y multilateral, proyectos y actividades llevadas a cabo bajo el “Plan Estratégico de Cooperación para el Desarrollo Integral”. Sus propios Estatutos gobiernan las funciones del FEMCIDI. El FEMCIDI consiste de la Cuenta para el Desarrollo Integral y de Cuentas Sectoriales las cuales fueron establecidas de acuerdo al Artículo 9 del Estatuto de FEMCIDI.

Todos los estados miembros participan en el financiamiento de actividades para el desarrollo a través de contribuciones Voluntarias al FEMCIDI. Los estados miembros pueden asignar sus ofrecimientos voluntarios para la Cuenta para el Desarrollo Integral y/o a una o varias de las Cuentas Sectoriales, en la proporción que cada uno de los estados miembros contribuyentes decida.

## **II. Estructura del Informe**

Este informe presenta la ejecución de las actividades programadas 1996 y 1997 en dos secciones separadas. Su estructura es la siguiente:

#### **IV. Contribución de 15% al Fondo Regular**

La Secretaría General registra la contribución del 15% de apoyo administrativo sobre la base de las obligaciones reales. En el caso de que los fondos de los programas fuesen desobligados, la contribución también se disminuiría proporcionalmente.

#### **V. Extensión del plazo para obligar fondos del FEMCIDI**

Los Fondos tenían que haber sido obligados en su totalidad al 31 de diciembre de 1997. Ante las dificultades presentadas para que las obligaciones cumplieran con el Artículo 94 de las Normas Generales, la CEPCIDI autorizó extender el plazo para contraer obligaciones hasta el 31 de marzo de 1998, según CEPCIDI/RES.22 (XXIX-0/97).

#### **VI. Cuenta de Ajustes de Fin de Año del FET**

Con relación a las actividades del FET cuyas apropiaciones caducaron al 31 de diciembre de 1997, ha sido necesario establecer esta cuenta en el nuevo año fiscal. El objeto es de registrar gastos incurridos en la ejecución de proyectos en los Estados miembros que llegaron a la Sede con posterioridad al 31 de diciembre de 1997. En esta cuenta se han registrado también ajustes asociados con el proceso de análisis y reconciliación vinculados con el cierre de operaciones de 1997.

#### **VII. Contratos de ejecución pendientes de firma de Agencias Ejecutoras**

Al 31 de marzo de 1998 se registró \$1.9 millones de obligaciones apoyados por contratos de ejecución que no habían sido firmados por las agencias ejecutoras. En el curso del mes de abril se normalizaron contratos por \$0.5 millones quedando \$1.4 millones pendientes de normalizar. En el curso del mes de mayo de 1998 todos los contratos que estaban pendientes quedaron firmados por las agencias ejecutoras.

### **VIII. Gastos:**

Los gastos incurridos durante el mes de **septiembre** fueron de \$2.4 millones. Al agregar esta cifra a la reportada al **31 de agosto de 1998** de \$22.3 millones, concluimos con un total de \$19.9 millones. Esta cifra representa el **74.7%** del total obligado.

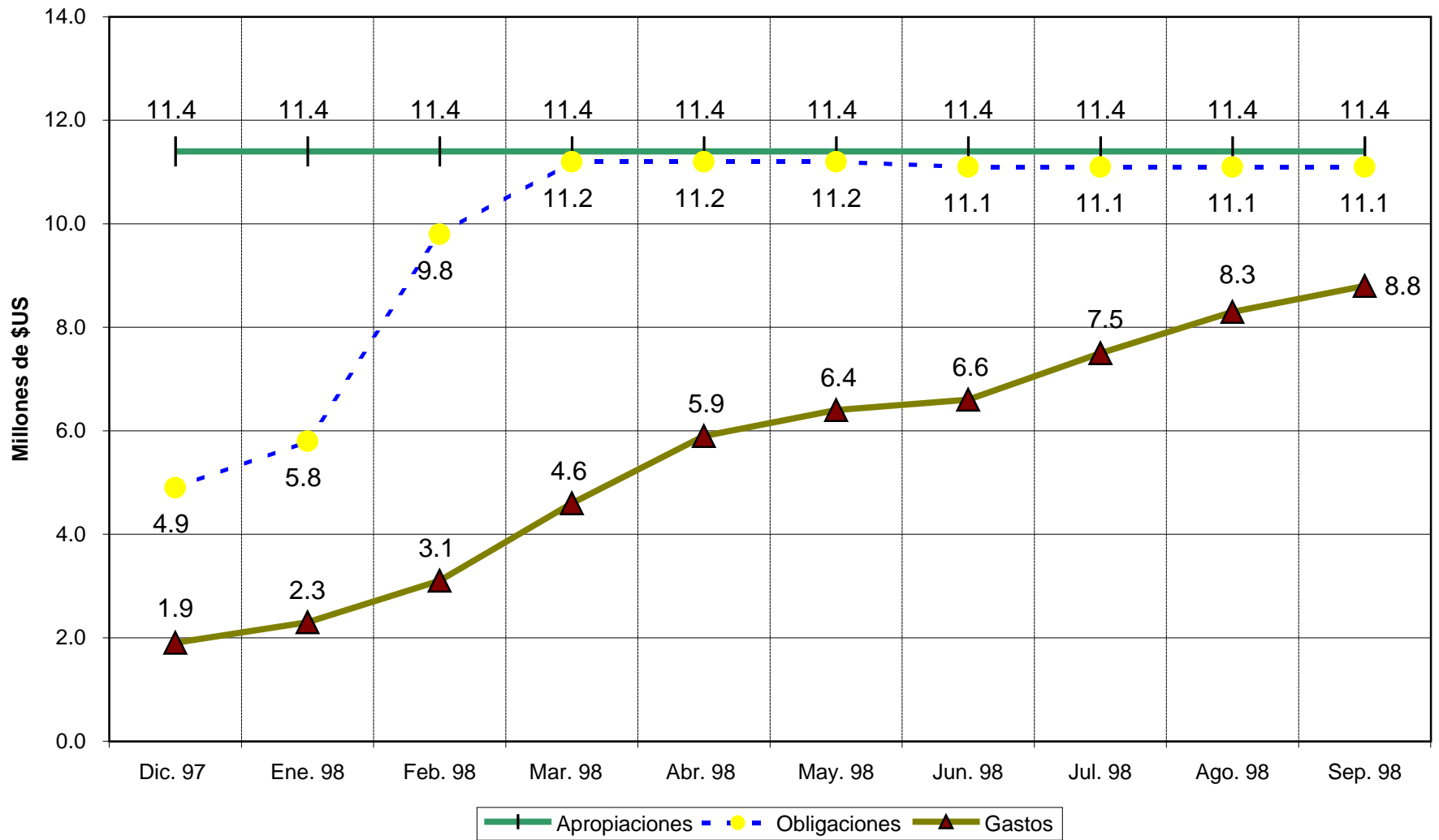

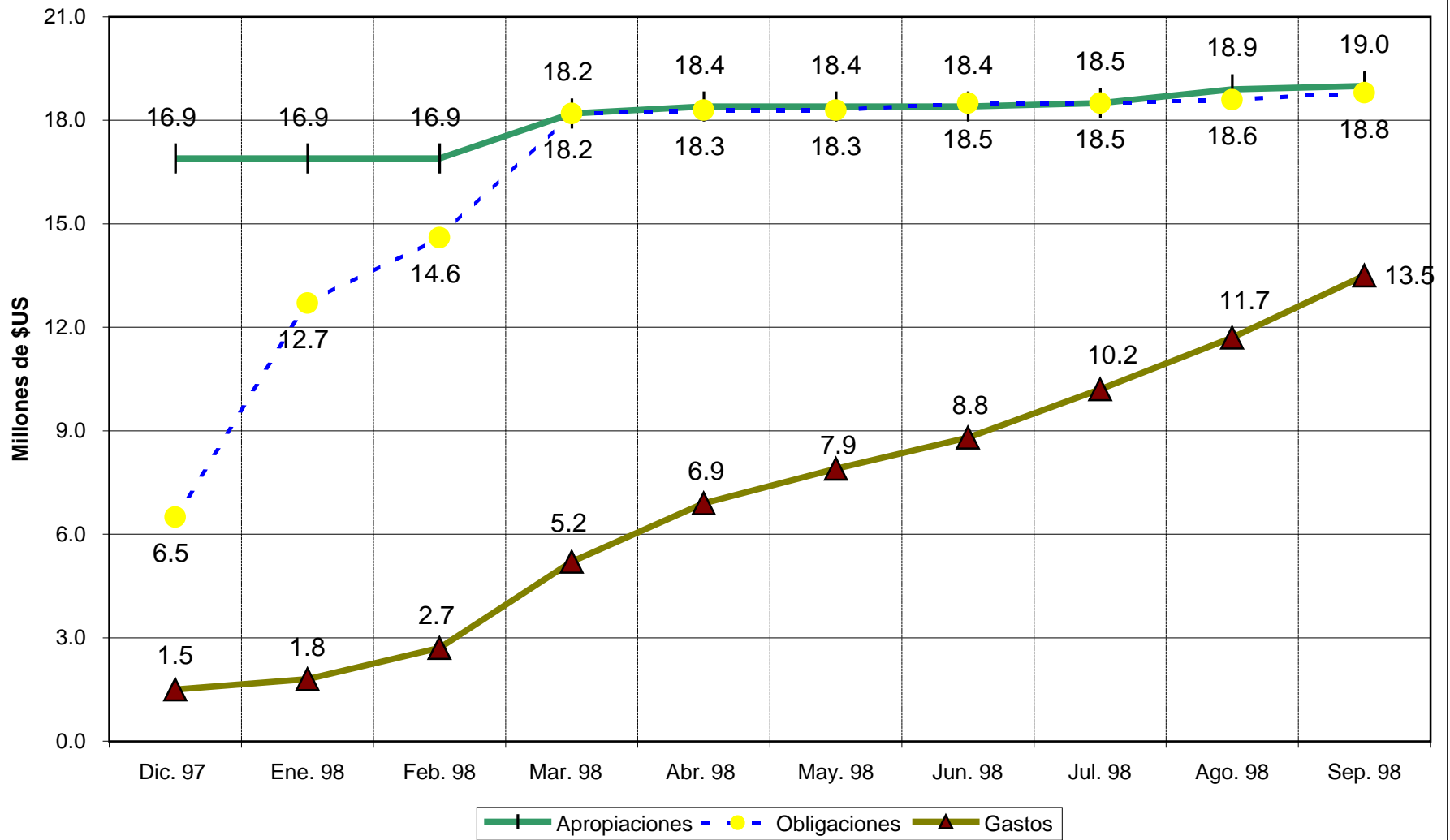

### NIVELES DE EJECUCION FEMCIDI 1996 31 de diciembre de 1997 al 30 de septiembre de 1998

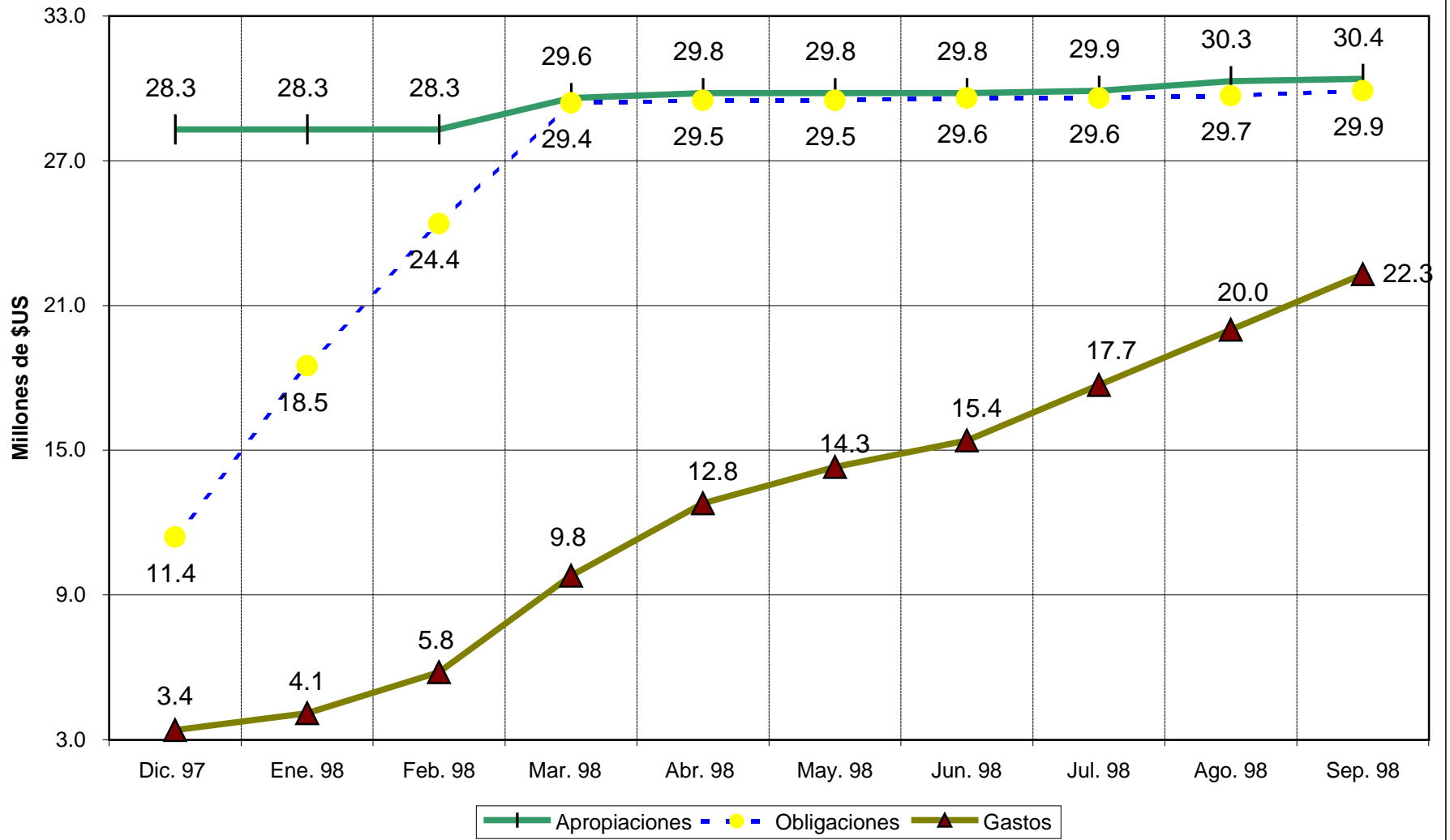




### NIVELES DE EJECUCION FEMCIDI 1997 31 de diciembre de 1997 al 30 de septiembre de 1998
