LEGAL FRAMEWORK

Constitutional Authority

Grenada Constitution Order 1973

Chapter I sect. 17 Governor General has authority to declare a state of emergency (SOE) by Proclamation (does not specify exercise is for natural or manmade disasters)

Recently applied: Statutory Rules and Orders No.24 of 2004 after Hurricane Ivan

LEGAL FRAMEWORK cont'd

Procedure for SOE

- Must be approved by resolution of both the Houses of Parliament
- □ In place for 6 months
- □ If longer new resolution by Parliament
- Section 17(8) Governor General to summon the
 Houses of Parliament to meet even if dissolved

LEGAL FRAMEWORK cont'd

Statutory Authority

Emergency Powers Act No. 17 of 1987

- □Vests Governor General (GG) with authority to declare SOE by Proclamation
- Defines "period of emergency" consistently with section 17 of Constitution (does not specify natural or manmade disasters)
- Declaration of emergency shall be revoked by the Governor General at any time.
- Governor General must act on the advice of Cabinet when exercising his powers

LEGAL FRAMEWORK cont'd

National Disaster (Emergency Powers) Act Cap. 3 of The 1990 Revised Laws of Grenada

- □ Vests Prime Minister with the power to declare and revoke declaration of national disaster
- □Powers exercised for maintenance of supplies and services on the occurrence of a national disaster (water supplies, electricity and gas and food and liquor supplies and all other measures) and to make associated regulations
- Defines national disaster to mean "hurricane, floods, earthquake, fire, outbreak of pestilence or of infectious disease or other calamity".

BUDGET APPROPRIATION & EXECUTION

- No legal or institutional provision for budget appropriation and execution
- No budget allocated for NADMA in the national annual estimates of revenue and expenditure
- All assistance through external flow of funds for pre and post disaster support (CDEMA, Red Cross, USAID, etc.)

SUMMARY & RECOMENDATIONS

Legislative Gaps and Recommendations

- Amend Constitution to vest GG (in specified circumstances) with power to declare a state of emergency without Parliamentary approval.
- Enact regulations to specify instances when this power may be exercised
- Expand provisions in Constitution, the Emergency Powers Act and the National Disaster (Emergency Powers) Act to include natural and manmade disasters
- Establish NADMA in law as a statutory authority

SUMMARY & RECOMMENDATIONS cont'd

Budget Appropriation and Execution

- Establish comprehensive fund for disaster management
- Establish insurance fund coverage for recovery efforts.
- Maintain public awareness for disaster preparedness plan
- Strengthen relationship between stakeholders and national Committees
- Enhance overall capacity building for disasters
