Sir Henry Fraser

One of Barbados' foremost heritage historians, Professor Emeritus Henry Stuart Fraser, KA, GCM, BSc, (Physiology, London U.) MBBS (UWI), PhD (Pharmacology, London U), FACP, FRCP, is a Barbadian doctor, academic, architectural historian, public orator, and Independent Senator. Professor Fraser has had alternative careers in art, architectural history and heritage preservation, tourism and public speaking. He served as President of The Barbados National Trust, (1989 – 1994) & Council Member for 32 years, as member of the National Art Gallery Committee and the National Town and Country Planning Advisory Committee; Chairman of the Barbados Tourism Advisory Council, the Task Force for the Nomination of Historic Bridgetown and its Garrison as a UNESCO World Heritage site, the Barbados National Trust Sentinel Committee, the Barbados National Trust Tyrol Cot Committee, Coordinator and Chairman, Conference of Caribbean National Trusts, in Barbados in May, 2014; Chairman of the Barbados National Task Force for the Preservation of Barbados' Built Heritage and the Preservation (Barbados) Foundation Trust.

Other publications include some 15 books, on architecture and heritage, for the UWI Press, Macmillan, and Miller Publishing, including *Island in the Sun: The Story of Tourism in Barbados*, and the new *Historic Churches of Barbados*; some 450 newspaper columns

Dr. Lorna Inniss

Dr Inniss is the Acting Director of the Coastal Zone Management Unit in Barbados for the past two years, and was the Deputy Director for the 10 years prior. She has previously held the posts of Marine Biologist and Coastal Planner with the Unit. Her research interests include innovative coastal conservation measures, submarine groundwater discharge in wetlands, as well as guiding risk and vulnerability assessment activities in respect of coastal hazards.

Dr Inniss has responsibility for guiding the technical work of the Unit and developing programmes in concert with Government and international donors that promote responsible ocean and coastal stewardship. She is Chair of the Natural Sciences Committee of the Barbados National Commission for UNESCO, and of the National Standing Committee on Coastal Hazards.

She is Barbados's focal point to the Intergovernmental Oceanographic Commission (IOC) of UNESCO, and helps to negotiate Barbados's position with respect to global ocean and coastal management within the United Nations system. She served as the elected Chair of the UN Intergovernmental Coordination Group for the Caribbean Tsunamis and Coastal Hazards Warning System from 2008-2012, and is the Joint Coordinator of a Group of Experts established by the United Nations General Assembly to deliver the first ever Integrated Global Marine Assessment.
