# 2.0 Abstract

Natural or manmade disasters in the Caribbean region have the potential to reverse development gains, compromise foreign exchange earning capacity, erode quality of life, destroy the islands' natural beauty and damage biodiversity. It is possible through policy congruence and physical planning, to mitigate the impact of natural disasters. In 2004 *Ivan*, the sixth most intensive Atlantic hurricane ever recorded, barrelled through the Caribbean and caused significant damage to the infrastructure and economies of Jamaica and Grenada in particular, with residual social and economic impact some five years later, despite the assistance offered by other nations and institutions to support national efforts at rebuilding.

Utilising our associates across the region and using face to face, virtual and telephone meetings and desk top studies, the ICG Group will research the legislative and institutional frameworks of regional territories with a special focus on the relevant powers available to the key actors for disaster management as well as any unavailable resources or associated bureaucracy that could hinder processes. We will review and compare budgetary allocations and mobilisation measures, existing best practices, legal and institutional gaps, together with national and regional and policy documents.

# 3.0 The Project Team and Experience
