Dante Negro (Moderator) is the Director of the Department of International Law of the OAS. He has served at the Secretariat for Legal Affairs for over 22 years, advising the Secretary General, the Permanent Missions of the Member States, the political organs of the Organization, and the Inter-American Juridical Committee.

He has participated as a speaker in various workshops, training seminars and high-level conferences inside and outside Latin America, and is the author of numerous articles on topics related to international law, especially on the role and evolution of the

inter-American legal system, the scope and content of various inter-American treaties, the Summits of the Americas process, international humanitarian law and human rights.

Dr. Negro is a member of the *Instituto Hispano Luso Americano de Derecho Internacional* (ILHADI), has lectured at a number of universities in the Americas and Europe, most recently at the master's on international protection of human rights at the *Universidad de Alcalá*, Spain.

He is an attorney (*Pontificia Universidad Católica del Perú*) and holds a master's degree in international law and human rights (University of Notre Dame, United States).



Ramiro Orias Arredondo is a member of the Inter-American Juridical Committee and Rapporteur for the legal regime of non-profit civil entities, the participation of victims in criminal procedures against corruption, and neuro rights.

He also serves as Senior Program Officer at the Due Process of Law Foundation (DPLF), a civil organization that promotes reforms that lead to better access to justice and judicial independence, involving multiple social actors.

As Founder and former Executive Director of "Fundación CONSTRUIR", Dr. Orias promoted and led public campaigns to improve access to justice by indigenous peoples and support the criminal justice reform process in Bolivia.

Dr. Orias has more than 3 decades' worth of experience in capacity-building and strengthening the rule of law, promoting election transparency, industrial modernization, and international cooperation, among others. He has also been General Counsel and Director of the Center for Conciliation and Arbitration of Bolivia's National Chamber of Commerce.

He has taught at the Diplomatic Cademy of Bolivia, the school of law at the *Universidad Católica Boliviana* and in the masters' in International Relations at the *Centro de Posgrado de la Universidad Mayor de San Andrés* (CIDES-UMSA) in La Paz.

Ramiro Orias holds a degree in Law and Political Science from the UMSS and a master's degree in International Studies from the *Universidad de Chile*.



Rafael Yuste is a Professor of Biological Science and Neuroscience, Codirector of the Kavil Institute for Neurological Research and Director of the NeuroTechnology Center at Columbia University. He is widely experienced in the fields of anatomy, physiology and the study of the relation between brain cell activity and behavior or mental states, through the understanding of the function of neuronal circuits.

Doctor Yuste is a member of the BRAIN initiative Working Group at the US National Institute of Health (NIH), and editor in chief of *Frontiers in Neural Circuits*, in addition to working on a project to map out the human brain and teaching and lecturing at the *Universidad Politécnica de Madrid*, the *Universidad de Navarra* and the technological institutes of Andalucía, Basque Country and Cataluña.

He was one of the main proponents of the 2021 constitutional reform in Chile to integrate mental privacy as a right guaranteed by the State, as well as a draft bill that seeks to define and protect the physical and psychological integrity of individuals.

Dr. Yuste earned a degree in medicine at the *Universidad Autónoma de Madrid*, as well as a Ph.D.at Rockefeller University in New York.



Amélie Kim Cheang serves as the Strategic Director of the Fundación Kamanau and, until December 2021, served as Executive Secretary of the Chilean Senate's *Consejo del Futuro*, launching and leading legislative and outreach initiatives around science, technology, innovation and knowledge. Within this framework, she led Latin America's most important scientific outreach event, *Congreso Futuro*, developing active collaboration with institutions such as the Nobel Foundation and world-renowned universities.

She previously worked at the *Agencia Nacional de Innovación y Fomento de la Producción*, CORFO, leading nationwide programs to attract international excellence centers to Chile, support *Investigación Aplicada*, *Desarrollo e Innovación* (I+D+i), and the restructuring of academic curriculum in the Nation's universities. Her tenure at CORFO concluded with serving as advisor to the Executive Vicepresident on institutional and international affairs,

Earlier professional experience includes serving as economic attaché at the Embassy of France in Chile and in organizations for the protection of children in France.
