THIRD AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING

BETWEEN

THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN STATES THROUGH ITS DEPARTMENT OF HUMAN DEVELOPMENT, EDUCATION AND EMPLOYMENT

AND

THE INTERNATIONAL INSTITUTE OF SOCIAL STUDIES OF ERASMUS UNIVERSITY ROTTERDAM

FOR

SCHOLARSHIPS TO THE ISS' MASTER'S DEGREE PROGRAM

The Parties, the General Secretariat of the Organization of American States ("GS/OAS"), through its Department of Human Development, Education and Employment ("DHDEE"), and the International Institute of Social Studies ("ISS"), a University Institute of Erasmus University,

CONSIDERING:

That the Parties signed the Memorandum of Understanding between the GS/OAS, through DHDEE, and ISS of Erasmus University Rotterdam for Scholarships to the ISS' Master's Degree Program ("MOU") on March 3rd, 2015, and have since amended the MOU through the First Amendment to the MOU on July 24, 2017 and the Second Amendment to the MOU on July 18, 2018;

That the Parties have mutually agreed to modify Article 3.1 and 5.1 of the MOU;
and

That Article 6.5 of the MOU provides for its amendment by way of a writing signed by the duly authorized representatives of both Parties,

HEREBY AGREE:

1. Article 3.1 of the MOU is hereby amended to read in its entirety as follows:

The total amount paid by GS/OAS under this MOU will not exceed USD 5,875 for four (4) OAS-ISS Scholarship Recipients, for a total of USD 23,500 and USD 3,750 for two (2) OAS-ISS Scholarship Recipients, for a total of USD 7,500, for a combined total of USD 31,000. To initiate the process for receiving that payment, the ISS shall submit the corresponding invoice, for a one-time payment, no later than October 15, 2019 to the Department of Human Development, Education and

Employment, OAS General Secretariat, 1889 F Street, N.W., Suite 760, Washington, D.C., with electronic copies to Yurismay Flores at yflores@oas.org and Jennifer Hoogdorp at jhoogdorp@oas.org.

2. Article 5.1 of the MOU is hereby amended and replaced with the following:


