THIRD ARTICLE OF AMENDMENT


Pursuant to Article 7.1 of the Memorandum of Understanding between the General Secretariat of the Organization of American States (GS/OAS), through the Executive Secretariat for Integral Development (SEDI) and Coherit Associates, LLC, (Coherit) concerning the Execution of Activities under the Third Phase of the Project "Expanding the Socio-Economic Potential of Cultural Heritage in the Caribbean" entitled "Enhancing the Framework for the Development of a Heritage Economy in the Caribbean", (hereinafter the MOU), signed by the GS/OAS and by Coherit on May 24, 2018, the duly authorized representatives of the GS/OAS and Coherit (together, the Parties) agree to the following:

1. Upon the signing of this Third Article of Amendment, Article 7.2 of the MOU shall be replaced with the following:

7.2 This MOU shall enter into force upon signature by the duly authorized representatives of the Parties and shall remain in force for 25 months, starting June 1, 2018 until June 30, 2020, which period may be extended by written agreement of the Parties.


