II. Webinar Structure

The webinar will be comprised of two presentations per day. The experts will present for 45 minutes, followed by 15 minutes questions and answer session with the participants for both presentations. For the question and answer sessions, participants will send all questions and comments in writing in the platform's Chat, please add your name and institution, so the moderator can read it along the question when reading to the experts.
