


Distribution of the 2014 OAS Regular Fund Budget (in thousands of USD)

- In the case of the IACHR, the original appropiation of Regular Fund (AG/RES.1 XLV-E/13) is USD 5,345.3 and includes: USD 4,372.5 for personnel and USD 972.8 for non-personnel. The modified appropiation is USD 4,812.5 and includes: USD 3,831.1 for personnel and USD 981.4 for non-personnel.

Funds Received by the IACHR in 2014 Distributed by Source of Funding (in thousands of USD)





IACHR Execution by Source of Funding - 2014 (in thousands of USD)





IACHR Execution by Object of Expenditure - 2014 (in thousands of USD)




