The UN Human Rights Council's complaints procedure provides an avenue for individuals and groups to report consistent patterns of gross human rights violations. The complaints are received and assessed by the WGC, which is made up of five independent and highly qualified experts. The WGC is responsible for reviewing and assessing the admissibility of complaints, determining whether they meet the criteria for consideration, and prioritizing them based on their severity and urgency. The complaints can be submitted by individuals, groups, or organizations, and can relate to violations of any human right, including civil, political, economic, social, and cultural rights.

**Expert member, rapporteur (2021), and vice-chairperson (2022-23)**

The Human Rights Council Advisory Committee is a body of 18 experts who serve as a "think tank" for the Council. The Advisory Committee functions under the direction of the Council and replaces the Sub-Commission on the Promotion and Protection of Human Rights. The experts who serve on the Advisory Committee are appointed based on their expertise, experience, and knowledge in the field of human rights. The Advisory Committee is tasked with developing studies and proposals on innovative and emerging human rights issues. Through its work, the committee supports the Human Rights Council in identifying urgent challenges and proposing creative and effective solutions.

The Advisory Committee plays an important role in shaping the Council's agenda and ensuring that human rights are promoted and protected around the world. The main studies I have worked on include the human rights implications of new and emerging technologies in the military domain (as a rapporteur), the impact of new technologies for climate protection on the enjoyment of human rights, neurotechnology and human rights, new and emerging digital technologies and human rights, national policies and human rights, technical assistance and capacity-building, and the right to development.
