



OAS Boot Camp on Migration and Protection

Globally, according to the United Nations, at the end of 2020, there were approximately 281 million migrants in the world, equivalent to 3.6% of the global population. Twenty-six percent of the world's migrant population lived in the Americas, meaning that migrants comprised 7% of the region's total population that year. At the same time, the number of displaced persons worldwide reached 117 million, of whom 9.2 million were displaced in the Americas. This figure represents an increase of 950% in the last 10 years. Latin America accounts for 28% of the global displaced population. What does this data tell us? That we are the region that migrates the most. This data confirms it, and the priority given to this issue at the regional level is also evidence of it.

The OAS has identified not only how crucial the issue is for political discussion and regional public policy but also the cross-cutting nature of the migration issue in all government portfolios, which have the responsibility to bring rights to all people, including migrants and displaced persons. From access to health, education, and decent work, to measures for regularizing and integrating these populations, the migration issue touches a wide range of spheres of government work, as well as civil society and academia. Likewise, it has been identified that those responsible for these agendas often have expertise in some areas but not in all those that are relevant, such as public communication on the migration issue, conducting actions to evaluate the impact of public migration policies, or raising funds and other support for work on the issue.

In order to fulfill its mandate to continue building institutional capacities in the region, the Department of Social Inclusion of the OAS Secretariat for Access to Rights and Equity inaugurates this intensive training program, the "OAS Boot Camp on Migration and Protection", to provide a rigorous, short-term immersion on what is key to know when working on issues related to migration and forced displacement at the regional level.



Our purpose

The purpose of the OAS Boot Camp on Migration and Protection is to provide comprehensive and specialized training to strengthen the knowledge and skills of participants in the areas of protection, assistance, and promotion of inclusion and access to human rights for migrants, refugees, and stateless persons in the Americas. The main objective of this program is to train participants to address the specific challenges and needs of these vulnerable populations, as well as to promote more effective, inclusive, and respectful human rights migration policies and practices in the region.

In summary, the OAS Boot Camp on Migration and Protection seeks to empower participants with the knowledge and preparation to be agents of change in the promotion and protection of the rights of migrants, refugees, and stateless persons. Additionally, it aims to contribute to the design and implementation of fairer and more equitable migration policies in the Americas, each from their portfolios of action.



Target Audience

Representatives of governments working directly or indirectly with migration issues or with migrant and forcibly displaced populations, as well as representatives of civil society, academia, the media, and other actors participating in the design of solutions and public conversations on the subject.



Objetives

- To train participants in international and regional policies and legal frameworks related to migration, forced displacement, and statelessness, as well as the protection of the human rights of migrants, refugees, and stateless persons.
- To provide knowledge on the elaboration, implementation, evaluation, and monitoring of public migration policies, including the participation of multiple actors and impact evaluation to guarantee the effectiveness and sustainability of the measures adopted from a perspective of inclusion and access to rights.
- To strengthen the communication tools and leadership skills of participants to advance agendas related to migration and forced displacement from a rights perspective, as well as to prevent and eliminate xenophobia and discrimination against migrants, refugees, and stateless persons.



METHODOLOGY



6 virtual sessions

The academic program will have a total duration of 2 weeks (3 sessions per week, 6 sessions in total). The sessions will be conducted live through the Zoom platform.

The virtual sessions will last two hours.

WHO CAN APPLY?

Government officials, members of civil society organizations, academia, and other key actors in the migration, displacement, statelessness, and international protection agenda may also apply. Other officials from other portfolios who have a demonstrated interest in social inclusion and human rights issues or who are working directly or indirectly with migrant and forcibly displaced populations may also apply.

Representatives of these sectors are especially invited if they are people in conditions of migration or forced displacement, Afro-descendants, Indigenous peoples, people with disabilities, women, young people, older persons, and LGTBIQ groups.

A balanced representation of stakeholders (government, civil society), gender, sub-regions of the Americas, urban and rural areas, and age, among others, will be sought.
