It works on the implementation of curricular educational policies by developing reference material, instruments and innovative research to improve pedagogical actions in the core areas of didactic materials, continuous training and evaluation, with a model focused on deep learning through systemic pedagogical coherence.

Its mission is to fight inequality in public education in order to ensure inclusive education through pedagogical techniques that take into account the different contexts and circumstances of children and adolescents. *Instituto Reúna* seeks to bring together educators, organizations, and educational networks from all over Brazil in a movement to develop best pedagogical and curricular practices in basic education.
