The information contained in this report is provided pursuant to resolution CP/RES. 759 (1217/99), “Guidelines for the Participation of Civil Society Organizations in OAS Activities.” This document includes a summary and a list of data and documentation presented by *Associação Jadir de Taekwondo* in accordance with the aforementioned Guidelines.

1. Background

The non-governmental organization *Associação Jadir de Taekwondo* was established in Brazil on April 12, 2000 to help children and young people living in vulnerable communities, using social and cultural change and sports projects. Its primary mission is to leverage the power of sports to nurture and educate children and young people, while helping them develop skills, for them to overcome adversities.

Associação Jadir de Taekwondo promotes support networks and operates around five key areas of activity: a) social inclusion, b) peace building, c) health and wellness, d) gender equality, and e) environmental education.

Seeking to empower children and young people, the *Associação* provides free Taekwondo lessons and interactive activities in under-served communities, where issues such as poverty and drug abuse are prevalent.

The *Association* is funded by donations from volunteers, partners, and individuals.

Associação Jadir de Taekwondo submitted its application to the OAS on May 6, 2022.

3. Primary areas of activity and contributions that could be of interest to the OAS

Associação Jadir de Taekwondo advocates for the rights of children and young people, nurturing their physical and mental strength and resilience that will help them develop lifelong good health and well-being. It also helps them develop skills such as leadership, empathy, communication, emotional intelligence and social responsibility, besides raising awareness in order to prevent drug use and abuse.

4. Identification of potential areas of collaboration with the OAS

Associação Jadir de Taekwondo proposes to support the OAS in the following areas:

- Working with the Inter-American Children's Institute to help develop public policies to guarantee promotion, protection, and exercise of the rights of children and adolescents in the OAS member states and to promote the building of a culture of rights, as part of strengthening democracy.
- Collaboration on mandates of the Inter-American Commission on Human Rights, and especially with the Rapporteurship on the Rights of the Child, with a view to strengthening respect for the human rights of children and adolescents in the Americas;
- Working with the Inter-American Drug Abuse Control Commission (CICAD) to reduce illegal drugs production, trafficking, and use, particularly by children and adolescents.
- Follow-up on implementation of mandates of the Summits of the Americas and resolutions of the OAS General Assembly and Permanent Council.
- Promoting participation by civil society organizations in activities organized by the OAS and registration of civil society organizations in the OAS roster.
