ANALYSIS OF THE APPLICATION FROM CENTRO DE DISCAPACITADOS VÍCTIMAS DE LA TALIDOMIDA EN CHILE (VITACHI) TO BE REGISTERED WITH THE OAS

This document was prepared by the Department of International Affairs/Secretariat for External Relations to provide information to the member states of the Organization of American States (OAS) on the civil society organization *Centro de Discapacitados Víctimas de la Talidomida en Chile (VITACHI)*.

The information contained herein is in response to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities," and includes a summary and a list of data and documentation presented by *Centro de Discapacitados Víctimas de la Talidomida en Chile (VITACHI)* in accordance with the aforementioned Guidelines.

1. Background

Centro de Discapacitados Víctimas de la Talidomida en Chile (VITACHI) was established on February 1, 2010, in Santiago, Chile, to protect and strengthen the rights of persons with disabilities. To that end, it encourages greater proactiveness in the design of public policies to ensure their provision of assistance, autonomy, integration, and advancement in society.

VITACHI organizes seminars on the human rights of persons with disabilities with the aim of fostering their social inclusion and raising public awareness. In 2012, it held four seminars, targeting community leaders in Estación Central, Maipú, and students in the Metropolitan Region. The events benefited more than 260 people by disseminating and sharing with them the contents of Law 20.422 (Law on Equal Opportunities and Social Inclusion for Persons with Disabilities in Chile). *VITACHI* also took part in the fourth meeting of the Committee for the Elimination of All Forms of Discrimination against Persons with Disabilities (CEDDIS) "Forging an Inclusive Americas," held in Santiago, Chile, from November 27 to 29, 2012.

VITACHI participates in the activities and seminars organized for civil society by the National Disability Service (SENADIS). It also stages press conferences and advocacy activities on behalf of people who took thalidomide (a prescription drug sold from 1958 to 1963 as a sedative for calming morning sickness in the first three months of pregnancy) and lobbies for the adoption of Draft Decision No. 237 by the House of Deputies of the Republic of Chile, which includes the creation of a register for anyone affected by the above drug and the establishment of appropriate compensatory benefits.

VITACHI is funded through contributions from its 48 members and carries out projects financed by the Junta de Vecinos Poblaciones Nogales, the Junta de Vecinos Comuna de Maipú, the Dirección Académica y Centro de Exalumnos del Liceo Ruiz-Tagle, and the Centro de Padres y Apoderados del Boston College.

VITACHI submitted its application to the OAS on Wednesday, January 30, 2013.

VITACHI promotes and protects the human rights of persons with disabilities. The main areas of activity and contributions of the CSO that may be of interest to the OAS include:
