Fundación Margen Apoyo y Promoción de la Mujer is a non-profit organization established in Santiago, Chile, on May 12, 1997, with the purpose of ensuring respect for and advancing the human rights of women sex workers.

Fundación Margen Apoyo y Promoción de la Mujer works in particular on prevention of and education on HIV/AIDS in the field and raising public awareness to decrease stigma and prejudice toward sex workers.

Fundación Margen Apoyo y Promoción de la Mujer places an emphasis on generating social and policy initiatives, as well as providing support for different parties through encouraging women sex workers to organize for the exercise, defense, enforcement, and regulation of their rights.

Fundación Margen Apoyo y Promoción de la Mujer receives funding through projects sponsored by the Red Umbrella Fund, the Robert Carr Fund, and government agencies, such as the Regional Council and the Regional Ministerial Secretariat for Health of Chile.
