The information contained in this report is in response to resolution CP/RES. 759 (1217/99), “Guidelines for the Participation of Civil Society Organizations in OAS Activities.” This document includes a summary and list of documentation presented by *ONG Proyecto TEPUY* in accordance with the aforementioned Guidelines.

1. **Background**

ONG Proyecto TEPUY is a foundation legally established on August 2, 2018, in La Florida, Chile to organize the Venezuelan diaspora in Chile in the areas of migration, work, school, and social counseling.

ONG Proyecto TEPUY has been engaged in this work since 2010 and was legally registered in 2018. It advises migrants on how to apply for visas and a decent job and provides information on renting. It also donates food, medicine, and health services, provides community activities for migrants, and offers psychosocial counseling.

ONG Proyecto TEPUY also engages in activities that raise political and institutional awareness to get laws and decrees passed that benefit Venezuelan migrants in Chile from the human rights standpoint.

ONG Proyecto TEPUY is funded by the Municipality of La Florida.

ONG Proyecto TEPUY submitted its application to the OAS on February 18, 2020.
