1. Background

Corporación Foro de la Juventud de Guayaquil - Ecuador is a nonprofit organization founded on March 30, 1995 in Guayaquil, Ecuador to promote the civic education for the citizenry by developing programs that promote comprehensive human welfare and the protection of human rights.

Corporación Foro de la Juventud de Guayaquil - Ecuador aims to promote youth leadership and social responsibility by developing education and training programs.

La Corporación Foro de la Juventud de Guayaquil – Ecuador conducts forums and events, such as the Youth Forum, and promotes the strengthening of youth organizations at the national level and the creation of forums for youth social participation, generating debate on matters of interest to society.

Corporación Foro de la Juventud de Guayaquil - Ecuador finances its activities from contributions from organizations such as the U.S. Agency for International Development (USAID), the United Nations Population Fund (UNFPA), the World Bank, and the Fundación Grupo Esquel Ecuador, among others, and from voluntary contributions from its members.

Corporación Foro de la Juventud de Guayaquil - Ecuador submitted its request for registration with the OAS on April 24, 2009.

3. Primary areas of activity of the CSO and their relationship to OAS activities

Corporación Foro de la Juventud de Guayaquil - Ecuador focuses on civic education for youth and promotion of their leadership and social responsibility. The following activities of the organization bear some relation to the work of the OAS:

- Promoting the protection of the rights and duties of youth;
