This document was prepared by the Summits Secretariat to provide information to the OAS Committee on Inter-American Summits Management and Civil Society Participation in OAS Activities on the civil society organization *Fundación ChasquiNet* (Chasquinet Foundation). The information contained herein is in response to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities," and includes a list of documentation presented by the *Fundación ChasquiNet* in accordance with the aforementioned Guidelines.

1. Background

The *Fundación ChasquiNet* is a nongovernmental, nonprofit organization that promotes the positive use of information and communication technologies in sectors with scarce resources, both nationally in areas of Ecuador and in Latin America and the Caribbean, in order to have an impact on economic and social policies. The *Fundación ChasquiNet* was established in 1999. Its main headquarters is in Quito, Ecuador.

The Fundación ChasquiNet runs several community support programs, primarily through the establishment of community learning centers in economically disadvantaged communities. It also provides advice and training to people wishing to learn more about information and communication technologies in order to improve their standard of living.

It derives its income from public funding sources, such as the governments of the Ecuadorian municipalities of Cayambe, Chaco, Guayaquil, Lumbaqui, Nabón and Quito, *inter ali*a, and private sources, such as Microsoft Corp., the Esquel Foundation, Global Knowledge Partnership (GKP), ImallsGlobal Inc., the International Development Research Centre (IDRC), German Technical Cooperation (GTZ), and the Italo-Ecuadorian Fund (*Fondo Italo Ecuatoriano* – FIE).

The Fundación ChasquiNet submitted its application on August 24, 2006.

3. Primary areas of activity of the CSO and their relationship to OAS activities:

The Fundación ChasquiNet works in the following areas related to OAS activities:

- Democratizing access to information by identifying needs and focusing on community-based projects;
