Fundación Haciendo Ecuador is a non-profit organization established on January 25, 2010 with the aim assisting with the planning, organization, generation, coordination, and implementation of social programs and projects that benefit various segments of Ecuadorian society.

Its mission is to foster democracy, transparency, and governance in Ecuador and the region.

The Foundation works on social and political-citizen advocacy projects within five core areas of activity: leadership, democracy, justice, education, and entrepreneurship with a cross-cutting emphasis on women and youth.
