This document was prepared by the Relations with Civil Society Section of the Secretariat for Access to Rights and Equity to provide information to the member states of the Organization of American States (OAS) on the civil society organization *Asociación de mujeres trabajadoras sexuales Girasoles Nicaragua* (Nicaragua Association of Sunflower Female Sex Workers).

The information contained in this report is provided in response to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities," and includes a summary and list of documentation presented by *Asociación de mujeres trabajadoras sexuales Girasoles Nicaragua* in accordance with the aforementioned Guidelines.

#### 1. Background

*Girasoles Nicaragua* is non-profit organization of female sex workers (FSWs) without partisan or religious ties. It campaigns for respect for the human rights and sexual and reproductive rights of its members.

The Association is part of the network of sex workers in Latin America and the Caribbean, with representation and voting rights in discussion and advocacy forums, and has signed agreements with state institutions such as the Human Rights Ombudsman's Office, the Supreme Court of Justice, the Ministry of Health, and the Nicaragua National Police.

It is funded mainly by projects and private foundations.

Girasoles Nicaragua submitted its application to the OAS on September 17, 2020.

- Promoting participation by civil society organizations in activities organized by the OAS and registration of civil society organizations in the OAS roster.
