This document was prepared by the Relations with Civil Society Section of the Secretariat for Access to Rights and Equity to provide the member states of the Organization of American States (OAS) with information on the civil society organization *Asociación Salvadoreña para la Formación y Capacitación Integral Sostenible* [Salvadorian Association for Education and Sustainable Comprehensive Training, ASAFOCAIS].

The information contained in this report is in response to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities." This document includes a summary and list of documentation presented by *Asociación Salvadoreña para la Formación y Capacitación Integral Sostenible (ASAFOCAIS)* in accordance with the aforementioned Guidelines.

1. Background

Asociación Salvadoreña para la Formación y Capacitación Integral Sostenible (ASAFOCAIS) is a non-profit organization that was established on September 5, 1998 in El Salvador. Its purpose is to contribute to integral development for Salvadoran families by providing professional and comprehensive development training on issues involving children and adolescents.

ASAFOCAIS seeks to include children and adolescents in El Salvador's productive system, in an atmosphere of equity, peace, and freedom, ensuring respect for human rights.

ASAFOCAIS works in the following areas:

- Citizen participation: through collaboration with state institutions and civil society to raise awareness among children and adolescents about human rights;
- Education: by promoting advocacy campaigns aimed at getting the Salvadoran government to increase budgetary allocation for the education sector;
- Sexual and reproductive health: by disseminating information and encouraging discussions on the topic in forums and conferences, communities, and at-risk population groups;
- Participation in international forums: by attending and participating in regional discussion forums.

ASAFOCAIS joins with networks in promoting campaigns and initiatives, such as the Partnership for Sexual and Reproductive Health; Campaign for a Convention on Sexual and Reproductive Rights; United Nations "Universal Periodic Review, El Salvador" campaign; Salvadoran Right to Education Network; and the Network for Children and Adolescents in El Salvador.

ASAFOCAIS finances its activities with funds from government institutions such as the Ministry of Health of El Salvador and the Municipality of Mejicanos, and from organizations such as

the Latin American Campaign for the Right to Education (CLADE), APROCSAL, and the Tinker Foundation.

ASAFOCAIS applied for registration with the OAS on March 13, 2014.
