This document was prepared by the Relations with Civil Society Section of the Secretariat for Access to Rights and Equity to provide information to the member states of the Organization of American States (OAS) on the civil society organization *Asociación de Mujeres por la Dignidad y la Vida (Las Dignas)*.

The information contained in this report is provided pursuant to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities." This document includes a summary and a list of data and documentation presented by *Las Dignas* in accordance with the aforementioned Guidelines.

#### 1. Background

Las Dignas emerged at the time of the peace accords of July 14, 1990, and was legally established in 1993 as an autonomous, diverse feminist non-profit organization that seeks to advance the integral development of women and fairer relations between men and women.

Las Dignas's mission is to promote the autonomy and empowerment of women and encourage them to make individual and collective transformations by challenging sexist socialization processes based on violence against women, sexual division of labor, exclusion from political participation, and control of their bodies, so that they can fight for the right to pleasure, to be happy, and equality.

Las Dignas seeks to contribute to the eradication of the patriarchal, heterosexist order and other forms of oppression and injustice, as well as to raise quality of life for, and fight against specific violence against, women through the construction of an organized force, political debate, awareness, advocacy, and feminist political pressure.

Las Dignas derives funds from donations, inheritances, and contributions, as well as from profits obtained from the investment of its assets and income from lawful activities.

Las Dignas submitted its application to the OAS on July 22, 2021.
