Asociación Civil Gurises Unidos is a non-profit nongovernmental organization founded on October 19, 1992, in Montevideo, Uruguay, with a mission to strengthen democratic processes to facilitate comprehensive development for children and adolescents as part of human rights defense and promotion.

Asociación Civil Gurises Unidos seeks to help create and execute comprehensive regional and national programs and initiatives to address the vulnerability faced by children and adolescents, especially those on the streets.

Asociación Civil Gurises Unidos provides input for designing public policies on children's issues through training for technical staff and trainers in the social, educational, and health care arenas.

Asociación Civil Gurises Unidos takes a comprehensive approach to working with children and young people and their families as well as with the community, to empower them to fully exercise their rights, through educational, recreational, and sport activities, as well as workshops, courses, and seminars.

Asociación Civil Gurises Unidos carries out its projects with funding from national and international organizations, among them the Center for Data and Studies of Uruguay (Centro de Informaciones y Estudios del Uruguay - CIESU), Ministry of Education and Culture, Uruguay Institute for Economic and Social Development (Instituto de Promoción Economico-Social del Uruguay -IPRU), United Nations Development Programme (UNDP), British Embassy in Uruguay, Embassy of the United States, European Union, and Save the Children.

3. Primary areas of activity and contributions that could be of interest to the OAS

Asociación Civil Gurises Unidos works in the areas of human rights, justice, and gender equality. The organization's primary areas of activity and contributions that might be of interest to the OAS include:

- Research at the national and regional levels on conditions which threaten the rights of children, so as to generate information that will help to defend and promote these rights.
- Influencing public policy on issues related to children's rights while contributing to the design of policies for children.
- Organizing best practices of states and civil society organizations that promote and protect the rights of children and young people at the national and regional levels.
- Establishing partnerships with national and international NGOs, public institutions, and research centers through reporting, provision of training, and promotion of social justice and human rights.

4. Identification of potential areas of collaboration with the OAS
