The information contained in this report is in response to resolution CP/RES. 759 (1217/99), "Guidelines for the Participation of Civil Society Organizations in OAS Activities." This document includes a summary and list of documentation presented by *Organización de Trabajadoras Sexuales* – *OTRASEX in* accordance with the aforementioned Guidelines.

#### 1. Background

Organización de Trabajadoras Sexuales – OTRASEX is a nonprofit organization legally established on August 12, 2016 in Santo Domingo, Dominican Republic. Its primary objective is to fight for the empowerment of female sex workers in the country. It works to fight social discrimination to offer a decent standard of living by providing programs, plans, and projects that enhance and improve the quality of life.

Since its establishment, *Organización de Trabajadoras Sexuales – OTRASEX* has pursued the goal of creating education, health, and social development programs for female sex workers.

Organización de Trabajadoras Sexuales – OTRASEX conducts multiple activities to promote and facilitate female sex workers' access to human rights, especially the right to life, physical integrity and health, work, equity, and nondiscrimination.

Organización de Trabajadoras Sexuales – OTRASEX conducts various activities to achieve the eradication of all forms of violence, exploitation or the forced labor of women, and promote a substantial change in the current legislation to create a statute on the profession and work of its members.
