1. Background

Centro de Estudios y Promoción del Desarrollo (DESCO), a non-governmental development institution, was founded in Lima, Peru, in 1966. It focuses on service and social development promotion and capacity-building for the poorest sectors of the society.

DESCO identifies itself as a public-interest, private civil society association that partners with grass-roots organizations, social and political stakeholders, and state agencies, to help build capacity for civil society and prepare development proposals.

DESCO has expertise and experience in issues of poverty and inequality, citizen participation, development and local management, promotion of local production, environmental management and planning, social management and evaluation, etc.

The CSO gets its income from a variety of public and private sources, including Oxfam, the European Union, the Spanish Agency for International Development Cooperation (AECID), the Latin American and Caribbean Network for Democracy, and *Fondo Empleo*, among others.

Centro de Estudios y Promoción del Desarrollo (DESCO) applied for registration with the OAS on October 5, 2017.

3. Primary areas of activity and contributions that could be of interest to the OAS

Centro de Estudios y Promoción del Desarrollo seeks to promote participatory development alternatives among the vulnerable population, to help empower them as citizens; and helps them exercise their political, economic, social, cultural, and environmental rights with a view to reducing inequality.

The primary areas of activity and contributions by *DESCO* that could be of interest to the OAS include:

- Public participation: to promote measures to foster development in Peru and other countries in the region and influence the formulation of development-oriented public policies.
- **Research:** to generate knowledge focused on development and the processes of building and strengthening democracy.
- **Citizen participation**: to promote citizen participation, transparency, gender equity, reduction of violence against women, the city, and healthy habitats.
