#### 1. Background

Las Reinas Chulas Cabaret y Derechos Humanos is a non-profit civil organization that was established in Mexico in 2014. Its mission is to generate artistic initiatives that use humor and pleasure to promote a break from corporal, cultural and institutional mores in order to build a more just, pleasant and happy society.

It is a feminist organization of lesbian and bisexual women that works in three core areas: (a) capacity building; (b) development of social projects with innovative methodologies; and (c) political management and advocacy; all with a human-rights and gender-equality perspective.

Its vision is to be a pacesetting feminist activist organization at the national and international level with an avant-garde cultural center that does solid work in the area of political management and advocacy.

The organization believes that inter-institutional work and the possibility of creating alliances partnerships government and civil society is the way to achieve a socially just world without violence and discrimination against the most vulnerable.

Las Reinas Chulas Cabaret y Derechos Humanos derives it funds from donations in cash and in kind from Mexican and foreign corporations, as well as from some government agencies for specific events. It also raises funds through its various activities.
