1. Background

CANACINTRA is a nongovernmental, non-profit, pluralistic, independent organization, that was established in Mexico City on December 5, 1941. Ever since its incorporation the organization has positioned itself as an effective instrument of mediation and solution of the problems faced by industrialists.

CANACINTRA's mission is to represent, defend and promote the interests of its members and the Mexican industrial sector, effectively influencing the development, sustainability, innovation, competitiveness and integration of industries, sectors and regions, through high quality services. Its objective is to promote the competitiveness and productivity of companies by helping them to stay up to date and become socially responsible agents of innovation.

CANACINTRA facilitates national industrial development by interacting with institutions at all levels and with the legislative branch. In addition, it engages with public and private organizations at the domestic and international levels to come up with solutions for the projects and needs of its members.

CANACINTRA obtains its income from its members' dues, the lease of its real estate, and procedures and formalities undertaken by its members.
