1. **Background**

Catholics for the Right to Decide - Mexico is a non-profit organization that was established in August 1994 with the objective of working to enable people to exercise their human rights, particularly those related to sexuality, human reproduction, and a life free of gender-based violence and discrimination, within a framework of social justice, intersectionality, and secularism.

The mission of *Catholics for the Right to Decide -Mexico*'s is to promote the secularity of the State, social justice, and cultural transformations from the perspective of progressive theology as well as incorporating an intersectional feminist approach.

Catholics for the Right to Decide - Mexico draws attention to and elevates the voices of believers who promote freedom of conscience and the recognition of moral capacity to make ethical decisions about life; promotes the implementation of public policies, and builds community by getting behind the transforming power of social organization.

Catholics for the Right to Decide A.C. -Mexico obtains its income through foreign donation agreements.

Catholics for the Right to Decide - Mexico submitted its application to the OAS on October 7, 2021.

Contributing to the Department of Social Inclusion of SARE in the formulation of proposals, plans, programs and, recommendations to achieve systematic gender mainstreaming and intersectional analysis in the organs, agencies and entities of the inter-American system.

Following up on implementation of mandates of the Summits of the Americas and resolutions of the OAS General Assembly and Permanent Council; and

Promoting participation by civil society organizations in activities organized by the OAS, as well as registration of civil society organizations in the OAS roster.
