Human Life International Inc. is a non-profit organization founded by Fr. Paul Marx, OSB on December 28, 1981, in Washington, D.C., United States.

The mission of *Human Life International Inc.* is "to defend the God-given life and dignity of all human persons from conception to natural death, as the natural family based on marriage, the fundamental human institution defined by a lifelong union between one man and one woman that is open to life." Its goal is to "build a culture of life and love around the world through education, outreach and advocacy."

Human Life International Inc. provides training to groups that have the greatest potential to influence the structures of society. In collaboration with local, regional, and national leaders, it provides educational and financial resources to support local programs that instill greater awareness of attacks on human life and the family.
